9707 Election of Deputy Town Mayor

The Town Mayor called for nominations for the office of Deputy Town Mayor.

Cllr Mrs Berry stated that she wished all votes taken on committees to be minuted as a recorded vote.

A councillor stated that she felt it was not necessary to take away delegated status as proposed as it was planned that the committee had 9 members 11 including ex officio and that was almost the full council. She stated that to return to non delegated status would mean discussing all issues twice.

A councillor questioned the reasons why the delegated status was proposed to be removed. The reply was that a smaller group had made decisions relating to large expenditure.

The clerk stated that Council could not make a decision on the delegated status at this time as standing orders stated that 5 signatures were required to reverse a decision taken within the last 6 months. The clerk stated that if 5 signed papers were received a special meeting could be called before the first meeting of the committee.

A councillor stated that he felt all expenditures should come back to full council for review as it was full council as a whole who were responsible for the expenditure in the eyes of the public.

A councillor stated that on next year once all new councillors had the experience of committees and decisions the numbers could be reduced again.

A councillor asked if caps on the spending limits could be placed on the delegated committees. The clerk stated that this was possible but standing orders would need to be changed and possibly financial regulations.

A councillor asked if a delegated committee could tie the whole council to expenditure. The clerk stated the answer was yes, although at full council this could be reversed. The councillor replied in saying that if the money had already been committed then the Council would have to honour that expenditure. The clerk agreed that would be the case.

A councillor stated that she felt Cllr Mrs J Voyce to be an excellent choice because of her experience as chair of personnel and outside experience with other agencies. She stated that she did not anticipate any problems.

A councillor asked what issue could arise. The councillor replied that if a member of staff had a problem they are supposed to go to the chair of personnel. If they feel they *cannot* go to the chair of personnel they should go to the mayor. In this situation which has arisen before. It is not appropriate to have a husband and wife where the staff have to go to one or the other. A councillor stated they could go to vice chair. A councillor stated that would mean a change in standing orders (and terms of reference) A councillor stated that there are other members on the

committee where issues can be raised, but agreed that would have to put into standing orders.

Cllr Mrs C Berry stated that she wanted it noted that she felt it was inappropriate to have husband and wife and Mayor and Chair of personnel at the same time.

She felt that Cllr M Cunningham would be a better choice to be the chair rather than deputy as she felt that was better for the staff.

The budgets were circulated to all councillors prior to the meeting and noted by all present. A councillor asked about cost centre 307. The clerk stated that code 4306 was a budget set to replace the shrubbery in Hailsham Road Flower beds and 1040 was the expected budget of income to be received during the year relating to advertising boards, as they are sponsored beds. A councillor asked if the council were out of pocket at present as some beds were not being sponsored at present. The clerk stated that the council were not out of pocket as monies had been carried forward into this years budget. However, there were some beds that needed looking at and advertising and refurbishing. Normally the sponsorship covers the costs of the general maintenance. This year some refurbishment would be arranged by the clerk with co-operation of the sponsors.

f) Income & Expenditure reports

The report was circulated to all councillors prior to the meeting and noted by all present.

g) New councillor courses

A discussion took place on who should attend, new and old councillors and whether the power of well being was included in this course. The clerk confirmed that it was. A councillor stated that he felt all of the courses were being held a long way away, including Uckfield. The Councillor asked to

liaise with Hailsham to see if a course could be arranged at the council offices for both town councils members to attend.

It was resolved to allow any elected councillors wishing to attend to be enrolled on a course. VOTE All in favour.

It was agreed that the clerk would look into the possibility of sharing a course locally with Hailsham and possibly Willingdon & Jevington and East Dean.

9724 Communications from the Town Mayor.

The mayor attended the 16th anniversary of the Woodside Hall nursing home on 11th May and was impressed by the care they offered to residents. The mayor also attended several events at the community centre during its 50th anniversary gala weekend. The highlight of the gala was the showing of some old footage of the 1968 Polegate steam engine rally, with some great shots of the high street before the Polegate Centre was built.

The high court has rejected the high court Pelham homes legal challenge to limit housing growth to 400 houses per year. Justice Sir Michael Harris, said that the request for a judicial review was premature. No doubt the secretary of state was waiting for the decision, prior to making his own decision on the Honey Farm appeal.

The Mayor stated that he was looking forward to the forthcoming Twinning visit on 1st – 5th June. Members from Saintry sur Seine will be visiting for the renewal of the charter on its 20th anniversary.

A date has been set for the Mayors summer tea party - Monday 4th July 2011 from 2-4pm at St John's church hall. Arrangements will be finalised at the next meeting of the festivities committee. As it is American Independence Day, the Mayor stated that would be the theme. The mayor stated that council should consider nominations for the 2011 civic award, and asked for ideas of worthy recipients please send those in to the office, along with any information on that particular person. This will then go back to the festivities advisory committee to discuss.

The mayor also requested that councillors limit their demands on the office, as this is a very busy time. For the benefit of the newly elected councillors, we request that queries are made through chairs of committees or the mayor and if you must contact the office please use email or telephone and only make personal visits when it is absolutely necessary.

9725 Town Clerks report including action list for information only

A councillor asked about the progress on the crossroads flower beds. The clerk stated that the maintenance person has carried out the remedial works trimming the shrubs, but that there was no interest from either the gardener's society or the rotary club contacted. Cllr Pybus stated that he knew contacts on the rotary and would pass these on to the office to make further enquiries to the sovereign rotary club (formerly of Polegate area).

A councillor asked about minute 9670 regarding the letter to Norman Baker and asked if we had had a reply yet? The clerk stated that the letter had been acknowledged only at that point and also that she had received a number of emails regarding the letter to the

highways authority (which had been erroneously forwarded by ESCC on to Highways Agency).

A councillor asked about minute 9682 dog bin location in the high street. He asked about Brookside, Brook Street and Hailsham road. The clerk stated that council had resolved to have a new bin to be located in the High Street near St Johns Church/ Church Road and that other areas had been considered but due to budget constraints this was the location selected and one extra emptying at Gainsborough Lane as requested by Wealden. The councillor was advised that the issue could be looked at again at the next Environment & Leisure committee meeting on 20th June.
