8189 Minutes of the Council Meeting held on 14 July 2008

8190 Matters arising from the minutes of the Council Meeting held on 14 July 2008

Cllr Mrs Bigsby asked about the thefts which had occurred – PCSO Beaden Reported that these were mainly from the supermarkets and petrol from Garage forecourts.

Members commented that parking was still an issue. Some of the new Double yellow lines had not been completed and this was making any Form of enforcement difficult. PCSO Beaden commented that the enforcement of the two hour parking restrictions was not always feasible or a priority for the PCSOs.

Cllr Mrs Berry was concerned about traffic coming down the wrong side of the road when the gates were shut – the traffic police have been told about this but the outcome of a court case is awaited as it may form a precedent. PCSO Beaden confirmed that speed checks cannot be carried out in the High Street by the barrier.

8193 District/County Councillor's Report

Cllr Roy Martin reported for the District and County. A petition had been signed by many concerned residents in the Western Avenue/Station Road area and a site meeting had been held with a County Officer but no formal decision had been made as yet. The contractors who had partially installed the double yellow lines had been asked to return a.s.a.p.

Wealden District Council had sent letters to Parish Councils about the K(telephone boxes in their areas. Electric blanket testing would be Taking place and Polegate was on the schedule. Wealden had written to Landowners in the District asking them to identify land which could be available for development.

Cllr Voyce asked Cllr Martin about further information on the Hailsham Eastbourne Triangle and what decisions may have been made. Cllr Martin had no further information as the Executive Panel had met but no report as yet had been received.

Cllr Voyce also asked where the Liberal Democrats had received their information from as they had recently published about 11,000 new homes being 'dumped' on Polegate. Cllr Watkins replied that these figures were the result of the regional housing figure being increased.
