After a lengthy discussion in relation to the parking and the possibility of the Premises becoming vacant a vote was taken and the outcome was 5 in favour and 4 against the application.

Proposed Reduction in Mandatory Speed Limit Traffic on Dittons Road and Pevensey Road, Polegate, East Sussex

Detailed plans have been received in the office from WSP Development and Transportation. This is as a result of a new mixed development on land north of Dittons Road, Polegate, a new access is to be provided off Dittons Road. This Access will comprise a new mini-roundabout on Dittons Road and the introduction of Traffic calming measures along Dittons, Pevensey and Station Road, between the A22 junction, to the east and the High Street to the west.

Comments should be sent back to WSP by 7th April 2010 by the Council.

A lengthy discussion took place in relation to the proposals. The proposal of the Reduction in the speed limit was generally welcomed by Council but there were Concerns over the lay-bys for buses being overlaid or in some cases moved. It was felt that the cycle path should be relocated along the bridleway which joins the Cuckoo Trail (Bridle Way 8) rather than trying to create a new cycle path and to Make the pavements narrow.

The Clerk will formulate a response to go to WSP which will be agreed by Cllr T Voyce.
