11795	Planning Application <u>WD/2016/1232/MAJ</u> – LAND ADJOINING CHAUCER BUSINESS PARK PHASE II, DITTONS ROAD, POLEGATE BN26 6JF – EXTENSION OF BUSINESS PARK COMPRISING ERECTION OF TWO-STOREY OFFICES TOGETHER WITH B1/B8 LIGHT INDUSTRIAL AND WAREHOUSE UNITS INCLUDING LOADING AND CAR PARKING FACILITIES. The application was discussed and the committee welcomed the new businesses and employment it would provide in the town. There were no objections to the application but there were comments made. The committee was pleased to see that appropriate arrangements had been made regarding the relocation of the wildlife. They were please to notice that there would be additional internal gated barriers. Comments were also made about concerns on the section of road where it is quite tight where it crosses the cuckoo trail entering J16 as mentioned in the ESCC Highways comments. The committee wanted reassurances that the fire hydrant would be attached to the mains. The committee also wanted to ensure that there was space for trade waste collections. It was resolved to submit no objections to the application <u>WD/2016/1232/MAJ</u> but to comment as follows: There were

SELF-CONTAINED ONE-BEDROOM FLATS. The application was discussed and the speed of the change around The committee expressed their disappointment in losing yet another important facility in Polegate. The podiatry had been moved to Hailsham and the hearing resource centre to Hampden Park near David Lloyd. The committee felt it had not been communicated well to either the town council or the residents what was happening. It was resolved to submit no objections to the application WD/2016/1262/DC with the following comments: Although the council understands the need for housing, the loss of the podiatry day care facility and hearing facility for the town was felt to be very disappointing. Although the services had been moved, this put Polegate residents at a disadvantage and inconvenience, particularly those using the podiatry services. The Loss of another important facility was not acceptable and the lack of communication with both the town council and residents and the speed at which it took place was also extremely disappointing.
