| <b>10519</b>      | <p><b>Parking Review</b></p> <p><b>a) Note responses from residents</b></p> <p><b>b) To make decisions on a submitted formal consultation from ESCC parking review proposals on newly submitted roads and Porters Way &amp; Brook Street</b></p> <p>Council noted the low response from residents and the mixed views. The overall views were in accordance with decisions already taken by council.</p> <p>Council discussed comments on the enforcement.</p> <p>Standing orders suspended</p> <p>Sergeant Mark Ritchie commented that PCSOs main duties were not enforcement, Pevensey sponsor a PCSOs and 2 1/12 hours can be sponsored to ensure that enforcement takes place. There are no traffic wardens in Polegate as the area has not been decriminalised by the county and district councils. He agreed that he would allow the PCSO to blitz areas when not carrying out other duties such as crime prevention, meetings, reassurance visits etc.</p> <p>Standing orders reinstated</p> <p>Council discussed the new comments re bus stops, additional lines at the Junction of Walnut Walk and Chestnut Drive. Council discussed the conflicting responses re Brook Street. 8/11 responses received were in favour of leaving the restrictions in place.</p> <p><b>It was resolved to submit the following comments to Highways: New yellow lines should be placed at the junction of Chestnut Drive/Walnut Walk. VOTE All in favour</b></p> <p><b>It was resolved that ALL bus stops should be marked accordingly (restricted) in Polegate.
